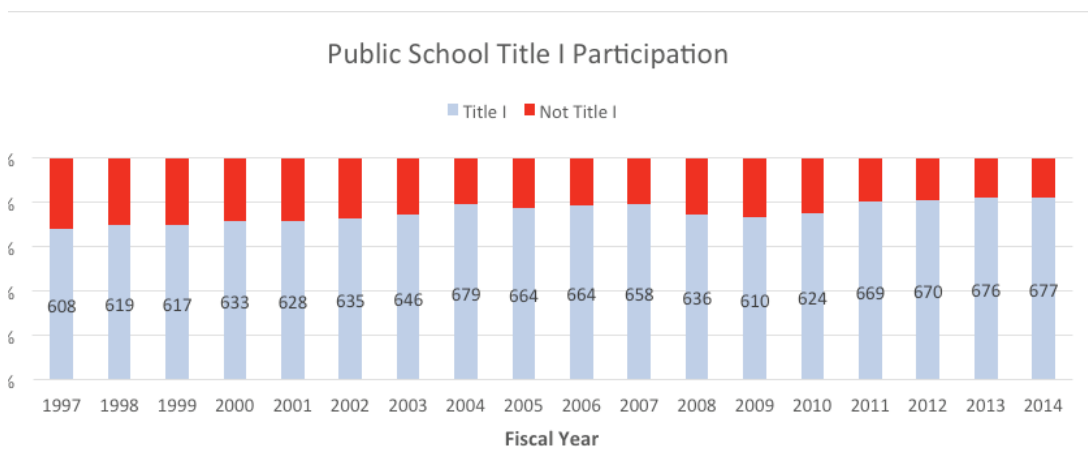
At-Risk Student Report

Montana’s definition of a basic system of quality public elementary and secondary schools includes educational programs for at-risk students (20-9-309, MCA). State statute defines an at-risk student as a “student who is affected by environmental conditions that negatively impact the student’s educational performance or threaten a student’s likelihood of promotion or graduation” (20-1-101(4), MCA).

Beginning in FY 2007, the Montana legislature provided \$5 million annually to local school districts for educational services for at-risk students (see Appendix 1). The at-risk student payment is distributed in the same manner as federal Title I funding. If a district is not eligible for Title I funds, it does not receive an at-risk student payment. The funding was provided for the first three years, but was not funded for FY 2009-10 and FY 2010-11. Funding was restored for FY 2011-12 and 2012-13. The law which establishes the at-risk student payment (20-9-328, MCA) requires the Office of Public Instruction to report to the Governor and the legislature on the change in status of standardized test scores, graduation rates, and dropout rates of at-risk students using fiscal year 2006 data as a baseline. This report reviews the status of these indicators.

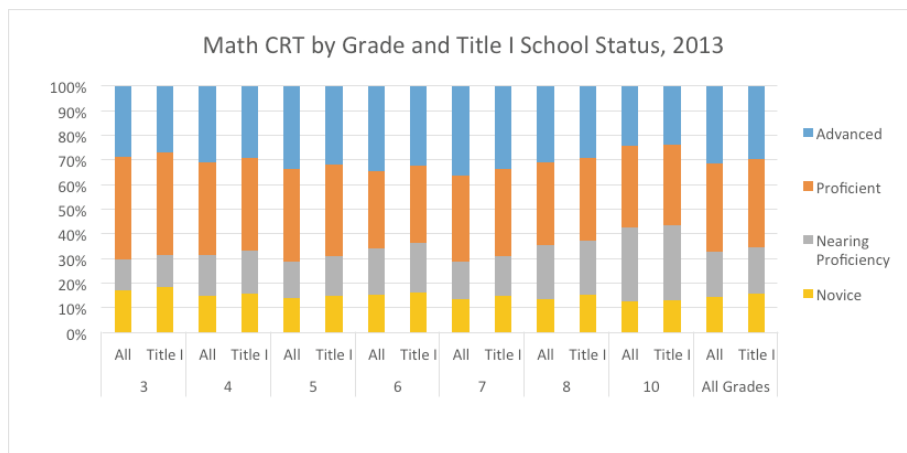
Population data – 2012-13 school year

- 112,647 students, or 78.9% of the PK-12 public school population, were enrolled in a school that received federal Title I funding.
- 82.1% of the public schools in Montana participated in Title I in the 2012-13 school year.
- Title I school participation decreased from 2008 to 2010, but has remained stable since 2011.

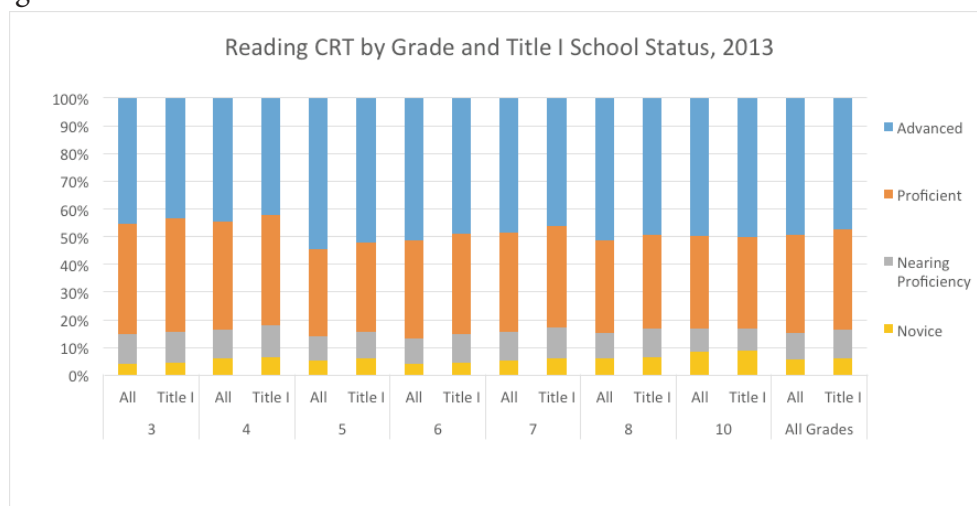


Testing data for this report is from the 2012-13 Criterion Referenced Test (CRT) for math, reading and science. This is the latest year of testing for math and reading with proficiency level data. The 2013-14 Smarter Balanced assessment field test does not provide student or school level proficiency data. CRT data includes public school data only, and does not include the state-funded schools (the Montana School for the Deaf & Blind, (Pine Hills or Riverside)).

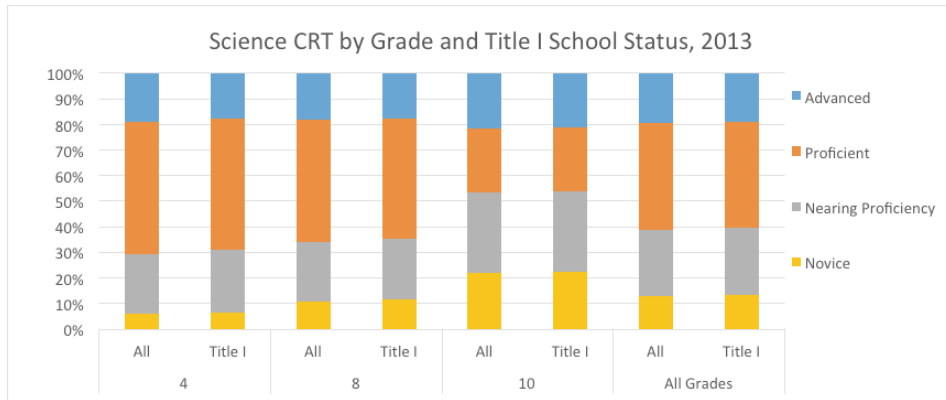
The chart below shows the percentage of students scoring at the Novice, Nearing Proficiency, Proficient, and Advanced proficiency levels on the Math CRT for the 2012-13 school year. The data is organized by grade and proficiency level, and separate columns are shown for Title I schools and for all tested schools. For all grades in 2013, the percentage of students scoring at the Novice level is slightly higher for Title I schools, and the percentage of students scoring at the Advanced level is slightly lower for Title I schools. In addition, the percentage of students below Proficient shows the same relationship to grade for both Title I schools and All Montana Schools, with the highest percentage of students below Proficient at grades 8 and 10, and the lowest at grades 3, 4, and 5.



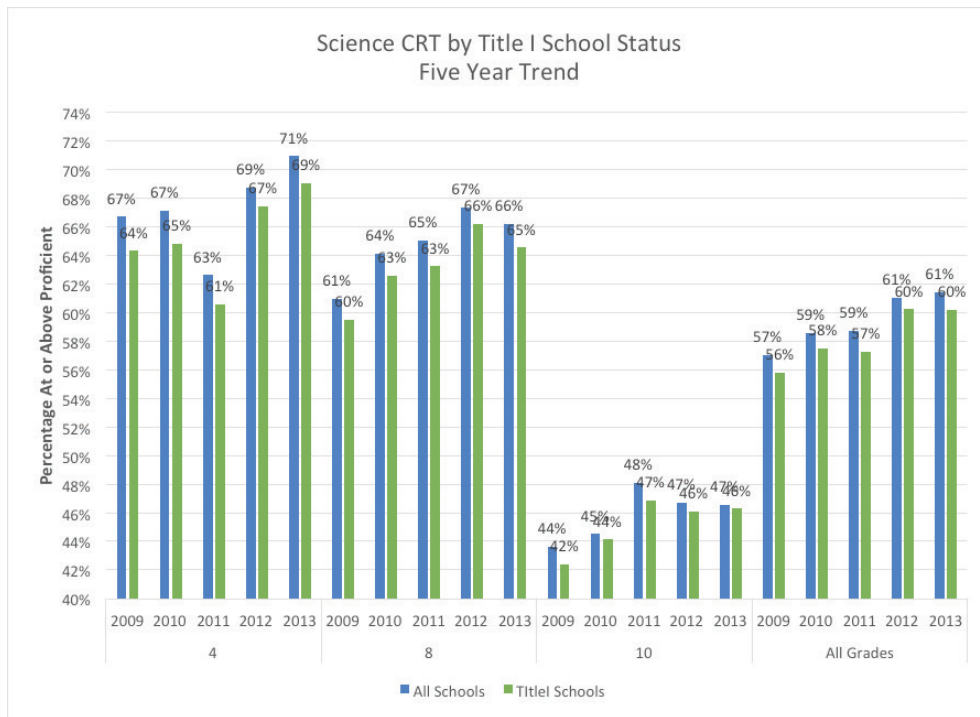
The chart below shows the percentage of students scoring at the Novice, Nearing Proficiency, Proficient, and Advanced proficiency levels on the Reading CRT for the 2012-13 school year. The data is organized by grade and proficiency level, and separate columns are shown for Title I schools and for all tested schools. For all grades in the 2012-13 assessment, the number of students at the Advanced level is slightly lower for Title I schools, and the total of students scoring below proficient (either Novice or Nearing Proficiency) is slightly higher for Title I schools. The highest number of Novice students occurs in 10th grade for both sets of schools.



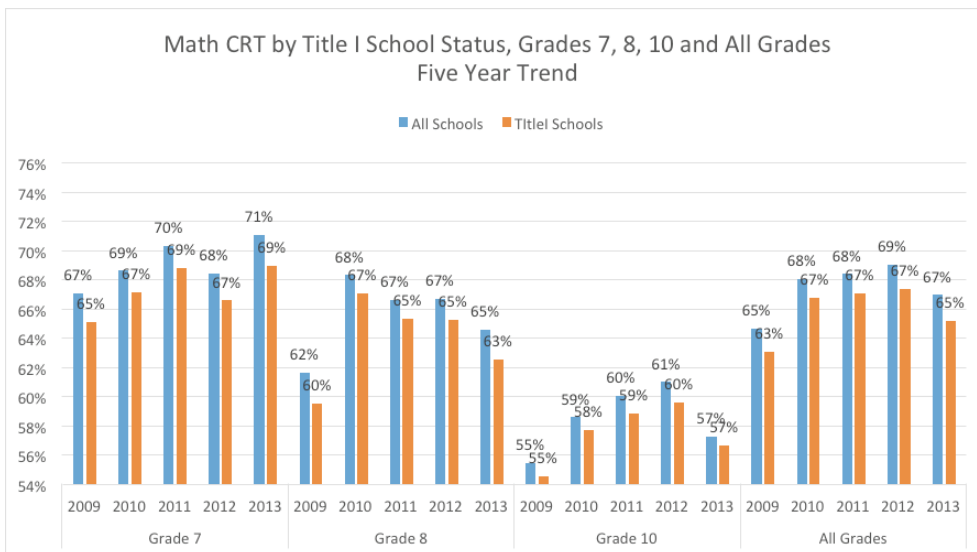
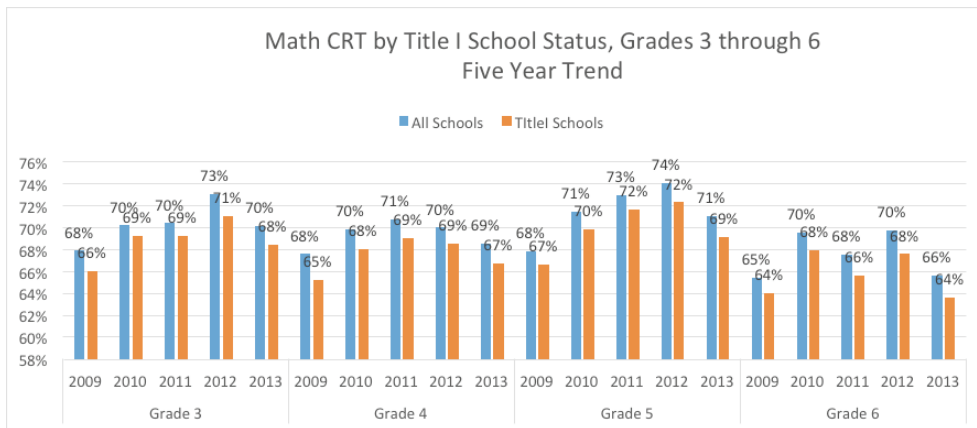
The chart below shows the percentage of students scoring at the Novice, Nearing Proficiency, Proficient, and Advanced proficiency levels for the 2012-13 Science CRT. The data is organized by the grade and proficiency level, and separate columns are shown for Title I schools and for all tested schools in Montana. Only grades 4, 8, and 10 are tested in Montana for the Science CRT.



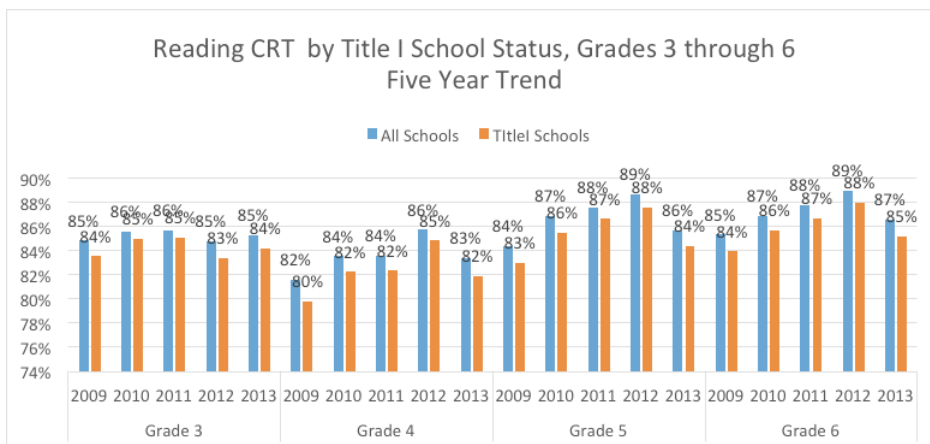
The chart below shows the percentage of students that scored Proficient or Advanced in the Science CRT for the last five years. Data are provided for each grade assessed, for each year of the assessment, and for both Title I schools and for all schools in Montana. Fourth grade students show a consistent gap of two percentage points between the Title I schools and all schools over the five year period, while the eighth and tenth grades both show a gap of one percentage point. Tenth grade scores have been lower than eighth grade scores by more than ten percentage points since 2009. Scores for all students increased each year until 2012-13, when the scores remained the same.

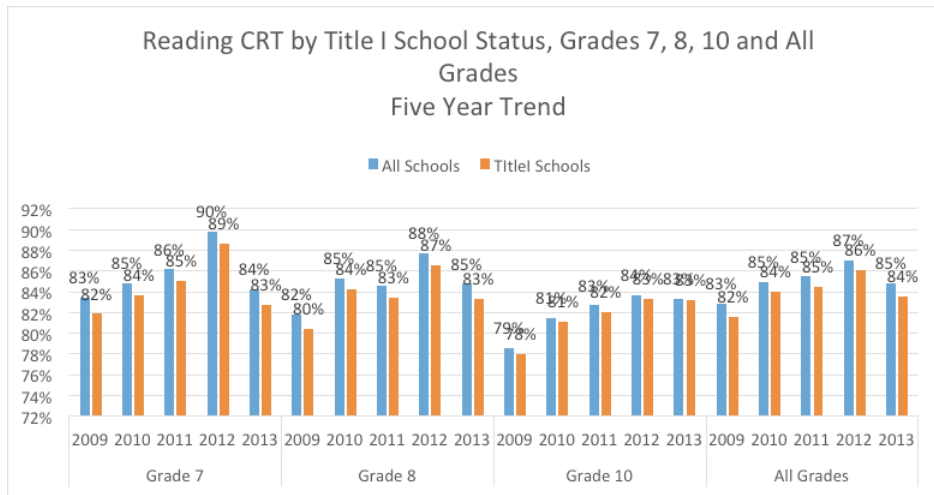


The two charts below show the percentage of students scoring at or above Proficient on the Math CRT. At no grade or year do the Title I Schools outscore the All Schools set, but the gap in all cases is within two percentage points. The gap is consistently smaller for grades 8 and 10 than for the elementary grades. Percentages of students scoring at or above Proficient have increased for both sets of schools until 2013.



The two charts below show the percentage of students scoring at or above Proficient on the Reading CRT. Fourth grade shows the greatest difference in proficiency percentages between the Title I schools and all schools (2 percentage points). The Proficiency percentage increased for both Title I schools and all schools until 2013. No gap greater than two percentage points is seen during the five year period.





Graduation rates – 2012-13 data

The completion rate* for students in Title I schools rose from 82.1% in 2010-11 to 84.3% in 2012-13.

The Four Year Adjusted Cohort Graduation rate was used for Adequate Yearly Progress (AYP) determinations from 2010-11 to 2012-13. This rate measures the “on-time” graduation of students, based on their entry into 9th grade four years earlier. The rate increased from 82.1% to 84.4% over this time period for all public schools.

The differences between the Title I schools and all schools is relatively small. Only the 2012-13 Four Year Cohort Graduation rate has a difference greater than 0.5% between the two sets of schools.

* **Completers** are the count of individuals who: completed the high school graduation requirements of a school district, including early graduates, during the previous school year, or completed the high school graduation requirements of a school district at the end of summer prior to the current school year.

Graduate is an individual who: completes a district’s graduation requirements in four years or less from the time an individual enrolled in the 9th grade. The Four Year Adjusted cohort graduation rate does not include students who transfer out of state or country, or who transfer into a private or home school.

Dropout rates – 2012-13 data

Dropout rates have decreased since the 2007-08 school year for all students, both at Title I schools and for the state. With the exception of an increase in 2011-12, the dropout rate for American Indian students has decreased since 2007-08 as well.

The difference in dropout rates between Title I schools and all schools has been very small (within 0.1%) since 2010-11, and the difference for American Indian students is nearly as small (0.2%).

Dropout rates shown in the table below are for grades 7-12.
