SUMMARY OF RULE(S): The Department of Administration (DOA) originally published MAR 2-13-566 concerning Public Safety Answering Points in December 2017. It included eight new rules, but one new rule was segregated into a new proposal because a portion of the rule proposed to be adopted by reference was not available directly on the website listed. Two of the subsequently adopted rules from the original notice referred internally to the segregated rule. In this amended notice, DOA updated the internal cross references within the adopted rules to properly refer to the re-noticed rule. Due to these changes, the Department rescheduled the associated hearing for April 19, 2018, and extended the public comment period to April 27, 2018. No other changes were made.

NOTES: The public comment period ends on April 27, 2018.
