To Whom It May Concern:

I certainly understand that the Commission has a great deal of work ahead of it as it considers how to split Montana into new legislative districts. The concern I have is how the rural areas often end up getting attached to a larger town in order to make the population numbers work out. But when this happens, the rural area often has nothing in common with the population center and therefore is ignored.

When I was living in Scobey many years ago, I was in HD 96 which included all of Daniels County, a portion of Valley County, and the town of Glasgow. The bottom line was that the population of Glasgow could easily out-vote the entire rural area. And now I live in House District 16 which includes a small portion of Toole County including the town of Sunburst, but we are thrown in with the majority of Glacier County (except most of Cut Bank). So I am living again in a rural area that is easily out-voted by the larger community in that Browning has so many votes that Sunburst is not represented at all in our elections. The census data from the 2000 census shows the racial differential in that HD 16 has approximately 30% white and over 67% Native American. This observation is not intended to be racial in nature, but shows how little impact north-western Toole County can have on an election when all candidates are from Browning. What is more frustrating is that I attempted to contact my Senator and Representative many times during this past session and had ZERO response. Why would a politician from Browning care about Sunburst if they don't need us to be elected?

I encourage the committee to do less gerrymandering to make population numbers work and leave house and senate districts more homogeneous.
