- ★ Ad Valorem taxes are divided into 1st & 2nd half installments. Special assessments are all payable by November 30th.
- ★ All taxes under \$10.00 are payable by November 30th.
- ★ **THIS IS THE ONLY NOTICE YOU SHALL RECEIVE.** So if you don't pay in full, save your tax bill with the 2nd Half Stub and send with the 2nd installment.
- ★ Taxes are due 1st Half-November 30th, 2nd Half-May 31st.
- ★ When either installment of Real Estate taxes become delinquent, a penalty of 2% is immediately charged, together with interest at the rate of 5/6 of 1% per month until paid.
- ★ **WARNING! DELINQUENT TAXES WILL BE SUBJECT TO TAX LIEN PURCHASES.**
