**Medical Condition Prior to Parole:**

Jennifer reports that her health was fair. She was diagnosed with depression and bi-polar disorder. Jennifer went to the Elkhorn Treatment Center where she was diagnosed with the flu that turned into pneumonia and then was diagnosed with H1N1 and she was hospitalized in Helena. She was then placed on a respirator on October 27<sup>th</sup>, 2009. On October 30<sup>th</sup>, 2009 she was transferred to Great Falls Benefits Hospital and was in the ICU unit.

On January 12, 2010, she was transferred from ICU to the rehab floor at Benefits.

On February 3, 2010, Judge Krueger amended her judgment and agreed to medical parole based on letter that DOC will pay for her care until she receives Medicaid.

On February 25, 2010, she was granted her medical parole,

**Current Medical Condition:**

She has pulmonary problems; she has about 52% of lung capacity. She has Hepatitis C and is in need of a liver transplant as well as a lung transplant.

She has applied for SSI and Medicaid. She was denied the first time and appealed the decision. She has a case manager with SSI and his name is Dale and he is the Disability representative and his number is 406-723-8246 or 1-800-545-3054. The field manager is Rick Elless. She was told that her papers are on the table for review.

**Health Care Costs/Payments Related to the Care of the Person:**

She is being seen by Dr. Pullman, John (406) 723-1300; Dr. Popovich, Keith (406) 782-8988 and Dr. Russell, Kathy (406-723-4075. She goes to Deann Johnson for physical therapy (406) 782-5887.

Dr. Pullman has an outstanding bill of \$3,292.00 as of June 1, 2010.

Dr. Popovich has an outstanding bill of \$ 2,486.75 as of June 11, 2010. She did have another appointment with the doctor on June 15, 2010, not sure of the amount on that visit.

Dr. Russell has an outstanding bill of \$ 755.50 as of June 21, 2010.

Deann Johnson for physical therapy has an outstanding bill of \$1,688.06 and her monthly bill for physical therapy comes to about \$629.55.

Her medications for a month are running about \$1,136.59 a month. Her medications changed in the month of June, until this time her meds were running about \$639.00 a month. There is an outstanding bill with the KMART Pharmacy in the amount of \$2,275.73.

She has an outstanding bill with Harrington Surgical for \$435.00 for a nebulizer, an oximeter respironics GO2 and a cane.

She is on Oxygen and her bill each month comes to about \$410.00. This bill has no balance as Blue Cross and Blue Shield with the DOC has been paying it. According to the billing department they are sending the bill to Sheri Townsend (406-444-7843) and it's getting paid.

Total amount due in medical bills is \$10,933.04. I have been sending the bills to Janes, Laura and McGraw, Wilda at the Department of Corrections. I have a few new ones that will be going out today (6-23-2010).

**Outcome/Adjustment to Supervision:**

Her outcome is that she needs a liver and lung transplant. She has good days and bad days. She counts a good day as being able to get out of bed.

She has signed up for Mental Health Help through Montana Western Mental Health.

Her adjustment to supervision has been good. She is reporting every two weeks right now. I have seen some improvement in her health in the way that her first visit with me was in a wheelchair and now she is walking with a cane.


**BACKGROUND:** William Ray entered MSP on July 7<sup>th</sup> of 2006, serving a sentence of (5) years prison with (1) year probation to follow for criminal possession of dangerous drugs, out of Cascade County. Mr. Ray had (2) prior felony convictions that occurred in January of 1990 for assault and a term of (5) years suspended and use of a dangerous weapon, (2) years consecutive. He had (2) probation violations and no parole violations.

He originally appeared before the Parole Board in January of 2007 at which time his parole was denied based on his poor history under supervision and his extensive history of misdemeanor convictions. The Board recommended anger management, CD and Meth-ITU. He was again denied parole in January of 2008 and set for a review in January of 2010. However, the Board recommended completion of the NEXUS program and pre-release. Mr. Ray applied for Medical Parole in June of 2008 and DOC Medical Director, Dr. Rantz diagnosis final stage liver disease and noted that he probably had less than (6) months to live unless he was given a liver transplant.

**CURRENT MEDICAL CONDITION:** Mr. Ray is deceased. He died of renal failure on November 5, 2008.

**HEALTH CARE COSTS PAYMENTS RELATED TO THE CARE OF THIS PERSON:**  
Mr. Ray is currently deceased and there are no costs related to his care.

**OUTCOME ADJUSTMENTS TO SUPERVISION:** Mr. Ray was released on Medical parole on August 13, 2008, and passed away on November 5, 2008. Records indicate that Mr. Ray was fully compliant during the period of his parole.
