RE: Budget Amendments

BUDGET AMENDMENT ACTIVITY

As of March 8, 2012 the Legislative Finance Division received notification of 39 budget amendments certified by the Governor since the December 2011 Legislative Finance Committee meeting. These amendments increase total funds by \$10.7 million in FY 2012 and \$0.4 million in FY 2013. An additional 2.13 FTE in FY 2012, and 1.50 FTE in FY 2013 have also been added. One amendment transfers existing authority between expenditure categories or between organizational units and six extend previously approved amendment authority. Figure 1 summarizes the budget amendments certified by the Governor from the period December 5, 2011 through February 23, 2012.

Each amendment, along with a brief explanation, is summarized in the attached table. Staff has reviewed the amendments and has raised no concerns with any amendment meeting statutory criteria.
