## **REDISTRICTING NEWS**

January 2, 2002 Vol. 1, Number 3

The first public hearings on proposed regional plans for new legislative districts for Northcentral and Central Montana were held November 13 in Great Falls and November 14 in Browning. The Commission will accept written comments on this region until February 7, 2001. Copies of the minutes are available on the website.

The Commission will meet for the next public hearings on January 16 in Havre and January 17 in Glasgow. Havre completes the hearings on the Northcentral Region and Glasgow will provide a public hearing on the Northeast region of Phillips, Valley, Daniels, Sheridan, and Roosevelt Counties and revisiting Hill and Blaine Counties. A mailing with maps, descriptions, and staff analysis has been sent to the Clerk and Recorders, Central Committees, and Legislators in the affected region. The meeting schedule is as follows:

The Commission will also meet February 19 in Miles City and February 20 in Lewistown, and in mid-March at which the first two regional plans will be tentatively adopted. The next region to receive staff visits will be the Crow and Northern Cheyenne Reservations and Big Horn and Yellowstone Counties area in January, followed by other counties in Southcentral Montana.
