






Graduates from 1989-2000 who were licensed to practice in MT in Sept. 2007








Dentists per 10,000 Residents

20 Mile Radii of Dentist Offices

10.8% Census 2000 Blocks Not Within 20 Mile Radius of a Dentist Office - Population = 97,208

1.7% Census 2000 Blocks Partially Within 20 Mile Radius of a Dentist Office - Population = 14,947

87.6% Census 2000 Blocks Completely Within 20 Mile Radius of a Dentist Office - Population = 790,040

Loan Repayment Incentive Programs

- 27 states have some form of loan repayment program for dentists
- 18 of the 27 states do not have a residency requirement to participate
- "...a shortage of outcome information exists from the state level." NCSL 2005
- "Early findings suggest that state loan repayment programs are a cost-effective way to improve access to oral health services in underserved communities." NCSL 2005



Service Payback Programs

- Montana currently does not require payback from students who do not return
- Seven of twelve WICHE states require some form of payback (AK, AZ, CO, HI, NV, NM, WA)
- Concerns associated with a payback requirement include
 - Decline in the quality of applicants
 - Loss of continuity of care in communities
 - Higher rates of specialization
